My lineage dates back to 316 A.D. with an impeccable Chain of Custody. In addition to my royal training, I hold a JD and two Doctorate Degrees. I am of high moral integrity, quality character and holy values.

As King, it is my task to identify and cherish that which is good in the world and to support peaceful coexistence for all humankind through Ho'oponopono resolution traditions.

I hereby approve the vision and works of your specialized inter-governmental organization, the International Human Rights Commission, to provide humanitarian aid, protection and respect for human rights around the world. Key to accomplishing this vision is your mission of developing international information and organizational activities that support communication between governments, government programs, as well as diplomatic missions.

Apology Bill. (U.S. Public Law 103-150 – 107 Stat. 1510) admits the invasion, overthrow, occupation, and annexation of 1893 violated diplomatic treaties, international law, Laws of Nations, and the United States Constitution. Under International law the World Court ruled the only appropriate remedy is restitution. That fact gives absolute right and power to restore independence. The U.S. Congress has no power, jurisdiction or authority to stop the restoration of the Kingdom. The United Nations Charter states: An autonomous independent sovereign nation-state contemplated under Article 1 of the Montevideo Convention on Rights and Duties of States requiring the state as a person of international law possessing the four qualifications of (a) a permanent population, (b) a defined territory, (c) government; and (d) capacity to enter into relations with the other states. The Kingdom of Hawai'i meets ALL LEGAL REQUIREMENTS - ALI'I NUI MŌ'I KING EDMUND K. SILVA. JR.

An excellent example of your activities is the ground-breaking efforts in the area of understanding the global impacts of illegal immigration and creating innovative answers through cooperative partners such as the new initiative with the Bissau Government.

The hundreds of active volunteers in the IHRC Special Monitoring Mission, protecting local rights and monitoring political situations, is an additional example of critical activities to protect human rights globally.

Na Kanaka Maoli, the People of Hawai'i, recognize our responsibility, our Kuleana, to spread the spirit of Aloha which is the love of everyone and everything. This spirit of Aloha for all those on Mother Earth compels me to step up in support of IHRC in an active way so that each individual will have the rights given under their Creator, supporting the opportunity to fulfill their own destiny.

In my language the word *Laulima* is on point. It means: Many Hands Working Together in Cooperation and Harmony.

Therefore, be secured in the knowledge that you have my full cooperation as King, of the Kingdom of Hawai'i in these international human rights endeavors.
