It is also in the process of opening next representative offices in Belarus, Algeria, Lebanon, Bissau Guinea, Switzerland and the USA. In addition, it has signed a memorandum of understanding with the Bissau Government on the establishment of the country's first novel barrage to stop the illegal migration of people from Africa to Europe.

**IHRC's mission** is to support and develop international information and organizational activities, as well as through active participation in current events in Europe and around the world, support of communication platforms between governments, government programs and diplomatic missions as well as participation in their creation.

To date, in cooperation with local organizations, the IHRC, has carried out humanitarian aid for over 236,000 people around the world, including refugees from areas subject to armed conflicts and their families.

Through hundreds of our active volunteers associated in the IHRC Special Monitoring Mission, we are active in all corners of the world, running humanitarian aid programs, raising awareness and protecting human rights, and monitoring local social and political situations.

We not only react to the situation, but also create the future of the nations of the world. This year, the IHRC will become the official patron of the WHO-certified drug factory in India, which will soon start producing unique vaccines for malaria and wenga. Undertaking this production became possible thanks to the efforts of the IHRC. Another factory producing these vaccines will be created in an African country designated by the IHRC. IHRC is also the driving force behind the creation and development of *IHRC Energy and Cost Saving Construction Building*, a patent and technology for building cheap and comfortable spherical homes.

Since mid-2017, the IHRC Foundation has been collaborating with the International Commission for Human Rights of the Civic Association (IHRC) to increase potential of humanitarian aid in the most vulnerable regions of the world. Therefore, began the creation of the International

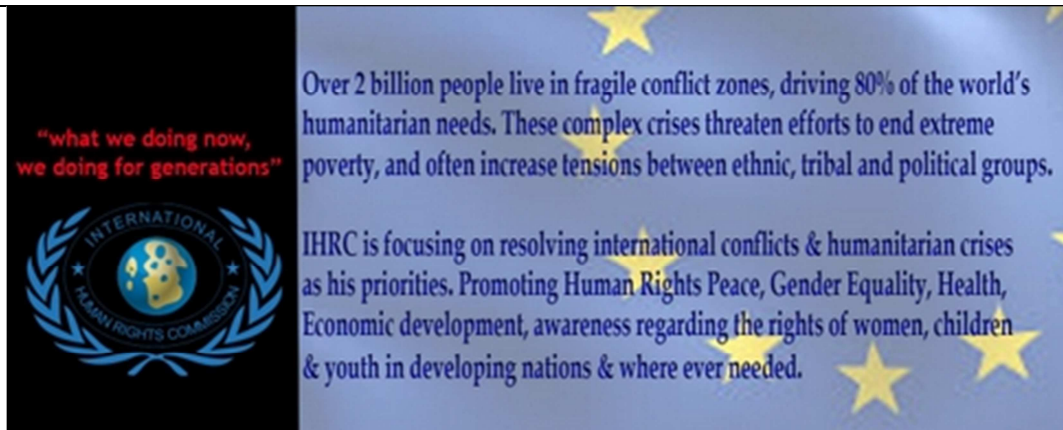

## PEACE MISSIONS



IHRC members are always there where armed conflicts, cataclysms, terrorist attacks, arbitrary rule arise ... and they always respond to the needs of the aggrieved and the deprived who suffer from the violation of rights, genocide, poverty, having to undergo lumpenization. World-wide IHRC members are active in the international arena searching for optimal diplomatic solutions.

The proposals of the IHRC group have found wide application in the preparation of this meeting as well as a partial solution to the problem in the east of Ukraine.

- ❖ The IHRC also helped to identify the personalities of illegal mercenaries from various countries fighting in the territory of Donbas, helped in the liquidation of terrorist groups Motorola, Ghost and Orient also by accurately pointing the places and personal details of people recruiting mercenaries. Thanks to IHRC's direct working contacts with the Prime Minister of Serbia, Alexander Vucič, a ban on imprisonment of all recruitment activities and the participation of Serbian citizens in military operations not conducted by the Serbian army was introduced there.
- ❖ One of the most important IHRC projects being implemented is "DAM 1". This project aims to stop economic migration to Europe from the African region by building centers creating economic and social conditions, inducing the local population to give up economic migration to Europe. As part of this task, the IHRC signed a Memorandum of Understanding (MoU) that ensures the government's sympathy and full cooperation with the IHRC to accomplish this task. At the same time, efforts to sign analogous MoU with the Government of Algeria are far advanced. In both these countries, the IHRC plans to establish a residence and training center,
